🚆 LA CROSSE AREA EMERGENCY RESPONSE FUND

Within one day of the Safer at Home order last March, La Crosse Community Foundation

and Great Rivers United Way developed and launched the La Crosse Area Emergency Response Fund. The fund was created to unite the community in responding to the crisis. A short, simple grant application was created so local nonprofits serving those most economically impacted by the pandemic could easily apply. A review committee met and made decisions within two business days of each submittal in an effort to rapidly deploy resources around community needs.

Grants have supported critical needs like childcare for essential employees, rent and other bill payment assistance, job navigation, services to help youth with mental health and education, new equipment to produce thousands of school meals for delivery each week, financial assistance for immigrants not eligible for other government funding, diapers, funding for food banks and pantries, and more.

The community response to this fund was awe-inspiring. The Franciscan Sisters of Perpetual Adoration provided a \$500,000 gift, with \$200,000 designated to support homeless outreach. And by the end of April, an astonishing \$1,000,000 had been donated to the fund from families, businesses, and individuals in the region. We even had a local eight-year-old donate \$5 and his lucky quarter!

By the end of 2020, the fund had distributed over \$1,000,000 in grants to support nonprofits and we expect the fund will continue to help well into 2021.

EMERGENCY SURVIVAL GRANT PROGRAM

The Safer at Home order began right at the onset of "event season" in our area, and we immediately started

to receive calls and emails from panicked nonprofit directors. In addition to cancelled fundraising events, many nonprofits had to cancel concert seasons, art shows, and museum admittance. For those with significant fixed costs, like owning a building, that sudden drop in revenue meant an imminent risk of closing their doors forever.

That's why we launched the Emergency Survival Grant program in June of 2020. The new grant program was created to provide nonprofits at risk of not surviving the pandemic with unrestricted funding to offset their general operating costs. We accepted proposals during our regular quarterly grant competitions in July and October.

Overall, 26 nonprofits received unrestricted funding totaling \$346,693. Grants ranged from \$1,000 to \$30,000 with an average award of \$13,000. This level of funding was possible with the help of many of our donor advisors, who contributed nearly \$70,000 from their funds to help support the Emergency Survival Grant requests.

ARTS & HUMANITIES CURATING HISTORY AND CREATIVITY

Todd-Robbins started the holiday gift program in 2019 after receiving a surprise \$1,000 on Giving Tuesday from the Barbara and Dave Erickson Fund.

EVIDENCE OF HELPERS AND HOPE EVERYWHERE

The relentless challenges of 2020 brought with them many opportunities to help. And our community has an absolutely inspiring number of helpers with a bias toward action. In fact, many of the grants we funded in 2020 were for newlythought-up ways to serve those most impacted by the pandemic.

To name just a few: Couleecap, Inc. created a new program to help people suffering financially from the pandemic pay critical bills, volunteers with Coulee Region Retired Senior Volunteer Program dedicated hundreds of hours to make thousands of masks for the community, and the YMCA kept their doors open during the Safer at Home order just to provide childcare for the children of essential workers.

As COVID brought much uncertainty and financial stress to nonprofits, we quickly understood our role as a helper was to listen to their needs and respond quickly.

When nonprofits said they needed help providing assistance to those most economically impacted by COVID, we worked fast to partner with Great Rivers United Way to raise over \$1,000,000 to rapidly deploy to local frontline nonprofits. When nonprofits said they were at risk of closing permanently, we created another emergency grant program to provide large unrestricted grants to help them cover their general operating expenses.

It's our local nonprofit community who, after all, inspires the work we do every day. They persisted through an impossible year of closures and cancellations, staff furloughs and layoffs, almost no live fundraising events, and more, to hold fast to their purpose in serving the community. And they did so in keeping who they serve at the forefront, reimagining how best to continue caring for those who need it most.

When we were overwhelmed by the needs coming from the community and asked for help, we were met with extreme generosity from fundholders and many new friends. Kids from a local neighborhood even made crafts to sell to raise money for the Emergency Response Fund and other area nonprofits!

As the challenging days of the pandemic seem to be nearing an end, we stay committed to being flexible and responsive to community needs. Together, and despite being apart, we are caring for each other, helping where we can with what we have, and giving hope for a better tomorrow.

We've supported for many years a Catholic nun who has a food pantry and helped buy a van for her because she delivers sandwiches for people who are living under bridges. Somebody else is doing the work and we're providing the means for doing it," shared John.

John and Everett are regular supporters of The Center: 7 Rivers LGBTQ Connection in La Crosse, supported the growth of a Hmong collection at the La Crosse Historical Society, and used their fund to support the new Black Empowerment Fund at the foundation.

DESIGNATED FUND SPOTLIGHT: SCOTT HENKE MEMORIAL FUND FOR THE CARE AND SHARE OF ANIMALS

The Scott Henke Memorial Fund for the Care and Share of Animals was established by his father Paul and sister Nicole following his passing in 2016. The fund is designated to support the care of animals in shelters as a meaningful way to honor the memory of Scott, an animal lover.

Scott Henke lived in Chicago with his beloved dog Charlie, and was just 44 when he passed. Whenever he needed to be out of town, he arranged for his animal-loving neighbor to care for Charlie, and also made provisions in his estate for the care and shelter of him. Scott was a regular contributor to nonprofits, especially animal shelters, and was active in groups that cared for animals.

The fund is designated to provide an annual grant to either the Sparta Animal Shelter, Trempealeau County Animal Shelter, Viroqua-Westby Animal Shelter, or the Coulee Region Humane Society.

Paul Henke also started the Ann Henke Scholarship Fund in his wife's memory, and is a member of the new Forever Society for those who include the foundation in their estate plan.

FIELD OF INTEREST FUNDS \$526,272 AWARDED IN FIELD OF INTEREST FUND GRANTS IN 2020

FIELD OF INTEREST FUNDS are established to benefit a specific cause or community need, such as environmental education, the arts, or homelessness. Spending from field of interest funds is advised by the board through the quarterly competitive grant program.

FIELD OF INTEREST FUND SPOTLIGHT: BLACK EMPOWERMENT FUND

The Black Lives Matter movement reignited a desperate cry for racial justice in 2020, sparking protests across the globe. Locally, growing awareness and advocacy left many feeling compelled to do more to disrupt the systems that uphold injustice and oppression and hamper progress.

That's why Sam and Jean Skemp of La Crosse stepped through our doors last fall; they wanted to make a significant donation that would help build racial equity here.

"Someone said to remain silent is to remain a racist. I agree with that and felt I had a moral obligation to help," said Sam, to which Jean added, "People here have not lived with much diversity. Often, they don't have ill will; they just haven't been exposed sufficiently to see the injustice."

After several conversations about how an endowed fund could address racial injustice here, the Black Empowerment Fund was created. The fund will support projects and organizations in La Crosse County working to advance racial equity, with preference given to nonprofits led by people from the Black community.

The Skemps began the fund with a \$50,000 gift, and after two \$25,000 successful matching challenges and many other gifts from the community, the fund today has over \$160,000.

As a field of interest fund, the Black Empowerment Fund can be used to support any application received through our competitive grantmaking program that fits its intended purpose. The La Crosse Dubna Friendship Association David Bell Memorial Fund was established in 2020 to provide annual support to the La Crosse Dubna Friendship Association. The fund name honors the integral role David Bell played as the leader in Russia promoting the sister city relationship with La Crosse; one the New York Times reported as Russia's best.

David Bell was born in Texas in 1921, and lived there until he was 10 when his father, inspired by the Russian revolution, moved the family to Russia. When Stalin came into power, his father was exiled to the Kazakhstan desert and the family was put on the street because they were Jewish.

As an adult, David became an English teacher and moved to Dubna, located at the confluence of three rivers about 70 miles north of Moscow.

In the late 80s, David heard of a peace lantern project in Leningrad led by physicians from La Crosse. David explored more connections to La Crosse, including a correspondence with former Mayor Patrick Zielke, and suggested a sister city relationship. A group in La Crosse formed that led the effort here. The relationship between the two cities was formalized with protocols signed on August 5, 1990.

The success of the La Crosse Dubna sister city relationship is evidenced by the breadth of the exchanges and numerous



Russia. The Russian garden in the Riverside International Friendship Gardens honors this special relationship.

The intent of this agency fund is to honor David Bell and the joint vision shared between the cities, promoting peace through understanding. The fund will be used to support the broad purposes of the sister city relationship.



AGENCY FUNDS are established by a nonprofit organization for its own benefit. Establishing an agency fund with a community foundation instead of managing their own allows nonprofits an added layer of protection for honoring the intended purpose of the fund. In addition to the organization's board of directors, the community foundation has a fiduciary responsibility to ensure the fund is used according to its original purpose.

In Tom's former capacity as executive vice president of Altra Federal Credit Union, and with Jan's service on the Centering Onalaska and Onalaska Education Foundation's boards, they each delivered their fair share of scholarship awards at the annual OHS scholarship night. Tom and Jan loved the excitement on students' faces as they were honored academically and recognized with a scholarship. And with the Brock's gratitude for a district that gave so much to not only their daughters, but several exchange students as well, they felt starting a scholarship fund was something they could do to give back.

After an excellent academic foundation in the Onalaska School District, both Katharine

and Elizabeth went on to graduate from college, get advanced degrees and get good jobs, one as a doctor at Children's Healthcare of Atlanta and one as a Sports Product Innovator at Nike. Tom and Jan are hopeful their scholarship will help others have similar opportunities.

Tom and Jan spent several years growing the scholarship fund while the girls were still in high school and college. Once it reached the desired level in 2018, the fund started awarding an annual scholarship. They appreciated not having to fund it all at once.

The Brock Family Scholarship will provide an annual scholarship to an Onalaska High School student who plans to study medicine, science, athletics, or business.

"We started the Brock Family Scholarship to recognize the school district's teachers and students, and as our way of saying thank you," shared Tom and Jan.

HOMELESS JESUS FUND

jon Stuttgen established the Homeless Jesus Fund in 2020 to serve as a beneficiary of his estate. The fund is designated to provide financial support for the immediate needs of people who are homeless and living on the streets of the city.

jon was born in north central Wisconsin into a Catholic family. As a young adult, jon was drawn to those who live unprotected in our society, people who are unsheltered, uninsured, and under-resourced. During graduate school, he volunteered at Port Ministries, an outreach to the homeless of Chicago's south side. Prior to that, he spent time with Bethany House, a homeless shelter in Fond Du Lac, Wisconsin. When jon returned to La Crosse, he worked at the Diocese of La Crosse doing outreach to Catholic students at UW-L and Western to keep them connected with their faith. He regularly took students to the Salvation Army, the Warming Center and Place of Grace where students met guests who frequented those places, some of whom were once university professors.

Students would often ask if they should help serve dinner or help clean up. jon's advice was first to get in line, get some supper, sit down and introduce yourself to somebody. Because service is not always about what we can do for someone. jon has learned that folks do not always want you to do something for them. Sometimes, in our attempts, we end up doing something to them. It's best to do something with those you hope to serve.

"I can't feed the world's hungry or shelter the world's homeless, but I can offer hospitality with whatever I have at the time. I can always be a friend. If that's all I can do, that has to be enough," shared jon.

2020 has been tough on jon as the health risks brought by the pandemic have forced him to isolate. His priority, after being vaccinated, is to go have supper with his friends at Our Savior's Lutheran Church or Sally's (Salvation Army), then maybe hang out at squirrel park (Cameron Park).

The name of his fund, Homeless Jesus, was inspired by a touching gift from friends of a miniature of the well-known bronze "Homeless Jesus" sculpture by artist Timothy Schmalz. jon hopes the fund provides freely for folks who need it, no strings attached.

jon established another designated fund in 2020 to receive part of his estate, the Hilda Stuttgen Memorial Fund for St. Clare Health Mission, in memory of his mother.

The board of directors bears the overall fiduciary responsibility of La Crosse Community Foundation. The board appoints and empowers a finance and investment committee comprised of individuals with extensive business and investment backgrounds for ongoing investment guidance, monitoring, and oversight. They strive to maximize investment income while following formal, yet flexible investment guidelines that incorporate prudent risk parameters, appropriate asset guidelines, and realistic return goals. Our investment portfolio is managed by Trust Point. Their representatives work with the finance and investment committee to continually review and update our investment policy to ensure it's responsive to current capital market conditions and the needs of the foundation. SUSTAINING FUNDS AND GIVING FOR THE COMMUNITY

Message from Finance Director Erin Belby, CPA

In 2020, the community foundation stepped up in many visible ways to address the unique challenges that the year presented: collaborating with Great Rivers United Way to start the La Crosse Area Emergency Response Fund, working with a generous donor to start the Black Empowerment Fund, and shifting our competitive grant process towards unrestricted funding through emergency survival grants to nonprofits.

Behind the scenes, we were also working hard to address pandemic-related challenges.

We took steps to make sure grant funds are available when they are needed most. We researched and re-evaluated our unrestricted assets to determine additional funding possibilities. We created an unrestricted surplus policy to provide guidance on minimum and maximum reserve targets. We identified a financial threshold that would in the future trigger the discussion of when/if additional funds can be available for grantmaking.

We took steps to make sure grant funds are available forever. We incorporated a rolling average balance calculation into our spend rate policy to stabilize future grant dollars through periods of turbulent market performance. And we continuously assess our investment policy statement to ensure our portfolio is in the best position possible for our perpetual funds.

We started looking at ways to "put our money where our mouth is" by evaluating what our commitment to
